## **OFFICIAL BULLETIN**

This bulletin is issued under the provisions of the MotorSport NZ National Sporting Code Article 18 in confirmation that the following amendments, notices or points of clarification have been authorised to the text of the Supplementary Regulations issued for the above named event. It is recommended that in addition to retaining a copy of this bulletin all parties modify the text of the regulations according to the following:

Item 1. Supplementary Regulations Part Two, Clause 1 Jurisdiction

Add Foreign Participation to wording, as below:

This event is a National Championship status Rally with Foreign Participation, in conjunction with the Manawatu Car Club and promoted by R2G Limited, and will take place on 23rd September in the Manawatu and Rangitīkei Districts.

Reason: To clarify Foreign Participation requirements for the event.

Item 2. Supplementary Regulations Part Two, Clause 2 Major Officials Delete Dale Budge Add Carl Fenn Reason: To advise change of NZRC Co-ordinator.

Item 3: Supplementary Regulations Part Two, Clause 3.3.1 Ceremonial Start.

Add: Cars must report to the Car Park on the corner of Kimbolton Road and Warrick Street, accessed via Warrick Street at their due report time. A Pre-Start List will be published for this purpose, which will be in addition to the Ceremonial Start list. Both the Pre-Area Start and Ceremonial Start lists will be published on Friday 22<sup>nd</sup> September at 10am

Reason: To enable cars to arrive at the Pre-Start area in the order in which they will be parked.

Item 4: Supplementary Regulations Part Two, Claus 3.5 Rally Week Schedule Amend as follows: New Drivers and RallySafe meeting 1600hrs

Reason: To advise change of meeting time.

Item 5: Supplementary Regulations Part Two, Clause 4.6 (2) Delete and replace with: Licence Requirements:

(a) New Zealand Competitors : Both No. 1 and No. 2 drivers shall hold a R1 or R2 Grade or higher MotorSport NZ issued Competition Licence.

(b) Australian Competitors : Shall hold a National Grade Rally Licence plus a Trans-Tasman Visa issued by Motorsport Australia.

(c) International Competitors : Shall hold a FIA International D-R Licence or a National Rally Licence together with a Visa (in English) issued by their ASN and a Medical Clearance Card.

*If the Entrant is other than a driver, an Entrants' Licence in the name of the Entrant is required.* 

Reason: To clarify requirements for foreign participation.







- **Item 6:** Supplementary Regulations Part Two, Article 14, Clause F Withdrawal from and rejoining the event. Amend as follows: NZRC registered competitors may rejoin at TC6C Service C out control to enable them to take part in the Power Stage.
- Reason: To clarify the NZRC rejoin point for the power stage.
- Item 7: Supplementary Regulations Part Two, Article 14, Clause G

Delete:- If for any reason SS7 McBeth cannot be completed by all NZRC cars, the results from SS3 Moawhango will be used to determine the power stage results.

Replace with:- In the event SS7 McBeth is interrupted for any reason, then the Clerk of the Course will use the results from SS3 Moawhango to determine the power stage results.

Reason: To clarify the process if SS7 is interrupted.
